

PURPOSE

Early childhood educators must be able to develop, communicate and demonstrate developmentally appropriate practices for children 3-5 years of age. Contestants' knowledge of early childhood education is evaluated.

ELIGIBILITY

Open to active SkillsUSA members enrolled in technical education programs with childcare as the occupational objective.

CLOTHING REQUIREMENTS

Official SkillsUSA white polo shirt or white shirt polo shirt without the SkillsUSA logo, black dress pants or black dress skirt (knee-length minimum), black closed-toe dress shoes. NOTE: Wearing socks or hose is no longer required. If worn, socks must be black dress socks and hose must be black or skin-tone and seamless/non pattern.

EQUIPMENT AND MATERIALS SUPPLIED BY HOST

1. Lesson plan sheets (NOCTI format)

2. Competitors will pick randomly from a sealed envelope which has their book choice order and their curriculum area listed.

a. There will be 10 books and the first person (according to the order picked) will pick a book, then a book will be replaced with another book choice and curriculum area. Each person will have 10 books to choose from.

3. Resource materials and supplies (A large assortment of materials and references will be provided).

EQUIPMENT AND MATERIALS SUPPLIED BY CONTESTANT

1. All students must have a one-page, typewritten resume.

SCOPE OF THE CONTEST - (DEFINED BY THE NATIONAL COMPETITION REGULATIONS)

(District Competitions are meant to be a scaled down version of National Competition. It is important for the students to participate in a competition that will reflect a cross-section of the industry skills needed to prepare them for the state and national levels)

1. Develop a lesson plan and materials for a basic concept from a curriculum area. The curriculum areas are math, science, food and nutrition, and social studies. The contestant will have one hour to complete lesson plans and materials. The theme will be assigned at the beginning of the one hour time limit. The contestant will be teaching the lesson to the judges for not more than 20 minutes. These 20 minutes include the reading of the book or parts of the book to the judges. After the one hour preparation, the contestants will choose a stick with a number on it to determine the order to present their lesson plans to the judges.



Students waiting to present will not be permitted to look at their lesson plans or make any further preparations.

2. Ten books will be provided at the competition site for the contestants to choose from. Five minutes have been included in the lesson presentation to accommodate reading the book to the judges. It is suggested that the reading of the book or parts of the book be included in the lesson plan itself.

3. Competitors will complete an oral interview conducted by the judges. Interviews will be evaluated based on the competitor's self-awareness and knowledge of Early Childhood Education Programs.

4. A 25 question multiple choice test worth two points each will be given on Child Development and General Preschool Teaching knowledge. (30 minutes to take the test)
